

ORDINANCE NO: 2007-3

AN ORDINANCE AMENDING THE TOWN OF TROY
ORDINANCE NOS. 2006-1 AND 3-86, S4 AND MUNICIPAL CODE SECTIONS
6.59.020 AND 6.59.040
RE: REFUSE COLLECTION FEES AND USE OF FEES

WHEREAS, the Town of Troy Municipal Code 6.59.020 and Ordinance No. 2006-1 provide as follows concerning refuse collection fees:

The Town of Troy hereby assesses a refuse collection fee of \$1.00 per week per household or business and a service fee of \$3.00 per month per household or business for the collection by the Town of Troy of one bag of refuse from each household or business within the corporate limits of the Town of Troy. The refuse must be properly and securely contained in a thirty-three (33) gallon trash bag that does not exceed twenty-five (25) pounds in weight. Each additional bag collected above the one bag allowed to each customer shall cost an additional \$1.00 per bag.

WHEREAS, the Town of Troy Municipal code 6.59.040 and Ordinance 3-86, S4 provides as follows concerning use of revenue in the Refuse Collection Fund:

The revenue obtained from the assessment of the refuse collection fee shall be placed in a fund designated as the "Refuse Collection Fund" and shall be expended therefrom for refuse collection expenses and landfill costs incurred by the Town of Troy.

WHEREAS, the refuse located at residences and businesses has become an increasing problem, necessitating the employment of the Town Marshall to enforce the refuse collection ordinance;

WHEREAS, the service fee of \$3.00 per month needs to be increased to \$8.00 per month because of the increased costs of collection and the costs of enforcement of this of this refuse collection ordinance by the Town Marshall.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF TROY, AS FOLLOWS:

SECTION 1

That the Town of Troy Municipal Code 6.59.020 and ordinance No. 2006-1 are hereby amended to read as follows:

6.59.020. Refuse Collection Fee.

The Town of Troy hereby assesses a refuse collection fee of \$1.00 per week per household or business and a service fee of \$8.00 per month per household or business for the collection by the Town of Troy of one bag of refuse from each

household or business within the corporate limits of the Town of Troy. The refuse must be properly and securely contained in a thirty-three (33) gallon trash bag and that does not exceed twenty-five (25) pounds in weight. Each additional bag collected above the one bag allowed each customer shall cost an additional \$1.00 per bag.

SECTION 2

That the Town of Troy Municipal Code 6.59-040 and Ordinance No.2006-1 are hereby amended to read as follows:

6.59.040 Refuse to be placed in "Refuse Collection Fund".

The revenue obtained from the assessment of the refuse collection fee shall be placed in a fund designated as the "Refuse Collection Fund" and shall be expended therefrom for refuse collection expenses, partial payment of the Town Marshall's salary to enforce this refuse collection ordinance, and payment of landfill costs, all of which expenses are being incurred by the Town of Troy.
